John Borelli, Jr., was recognized by The Guidance Center at its sixth annual Mental Health Distinguished Community Leadership Awards Dinner held on Wednesday, November 14, at Merighi's Savoy Inn in Vineland.

Borelli received the prestigious community leadership award for his outstanding contributions and service to the greater **Cumberland and Gloucester County areas** and to The Guidance Center. He was recognized and thanked for his dedicated work supporting law enforcement, education, mental health, business, and the environment in our local and regional communities — making it a better place to live for all of its residents through his leadership, volunteerism and advocacy.

mental health, law enforcement and education is undeniable, along with his advocacy for numerous civic organizations that are the fiber of our southern New Jersey communities. John is truly a man of integrity and principle with genuine concern and compassion for others."

A lifelong resident of Malaga, New Jersey, John serves as president/CEO of Newfield National Bank, an independent, full-service community bank that was founded in 1934. Devoted to supporting law enforcement and firefighting, John served as a volunteer firefighter for the Malaga Fire Department from 1976 through 2001, holding the titles of lieutenant, captain, assistant chief, and ultimately chief of the department from 1981 to 2001. TGC mental health training workshops offer specialized education to our mental health providers

The Guidance Center hosted a number of training classes in 2019 for area mental health care providers. Some topics included Mindfulness-Based Stress Management, Motivational Interviewing, Trauma-Focused Treatment, Crisis Intervention Prevention, Service Excellence for Social Service Providers, and Ethics and Professional Boundaries. These training workshops were held in the Fenton Building at The Guidance Center in Millville, New Jersey. Each professional development training qualified for LPC and LCSW Continuing Education credits.

Trainer Tom Stromberg, a clinician and educator with Babcroft Behavioral Health, a provider of specialized care to children and adults, presented training entitled *Crisis*Intervention/Prevention to Guidance Center staff on April 11.

This course offered strategies for preventing crisis situations including examination of staff behavior and its effect on individuals served. The class provided behavioral guidelines for positive interactions, antecedent management for preventing crisis, de-escalation techniques, relaxation strategies and basic counseling skills for crisis prevention.

Most recently, Dr. Jorge Priori, past medical director at The Guidance Center, presented a training session on Medication Education on November 19. Dr. Priori presented updates on psychotropic medications. Attendees gained knowledge of psychotropic classifications, symptom responses, identification of side effects, sun and heat precautions, and discussion on the best treatment outcomes when combining psychotherapy and psychotropic medication management.

The Guidance Center participates in the NJ Department of Labor and Workforce Development (NJLWD) training consortium grant, which provides trainings to TGC staff on site, that increase knowledge and skill base integral to providing quality service to our consumers.
